Seventh heaven? Burnham's honeymoon hits the buffers

WESTMINSTER – 26-29 AUGUST 2026

Andy Burnham is Britain's seventh Prime Minister in a decade, and he has only had the keys to Number 10 for five weeks. No general election, no manifesto, just a resignation, a coronation and a removal van. Commentators reckon the poll bounce (Labour has actually nudged ahead of Reform UK for the first time in months) will not survive contact with the Budget on 28 October. The honeymoon is nice while it lasts.

- Burnham became PM on 20 July 2026 after Keir Starmer resigned following months of cabinet resignations.
- His top team includes John Healey at the Treasury, Yvette Cooper at Health and Ed Miliband as Foreign Secretary.
- David Lammy and Peter Kyle were among those dropped in the reshuffle.

WHY THIS MATTERS FOR YOUR A-LEVEL: your textbook tells you the UK has no fixed method for choosing a new PM mid-term, and that a leader can be replaced by their own party without a general election, because it is the Commons majority (not the voters) that technically installs a government. Burnham is that abstract rule made flesh: no dissolution, no polling day, just an internal Labour contest and a trip to the Palace. Use this as your go-to example next time an exam question asks you to evaluate "elective dictatorship" and party control alongside the monarch's formal role in appointing a PM.

Asylum hotels: half the rooms, none of the peace

WESTMINSTER – 27 AUGUST 2026

The Home Office reckons it is winning. New figures show the number of asylum seekers stuck in hotels has been cut in half in a year, down to just over 16,000. Home Secretary Shabana Mahmood is out trumpeting record illegal working arrests and rising deportations. Critics say the numbers dodge the bigger question: small boat crossings still made up four in ten claims, and the hotels have not shut yet.

- Hotel-housed asylum seekers: 16,021 in June 2026, down from 32,041 a year earlier.
- Total asylum applications fell 21% year on year, to 85,891.
- Asylum spending down 8%, to £4.36 billion.

WHY THIS MATTERS FOR YOUR A-LEVEL: do not just file this under "the government talked about immigration." Notice how Mahmood built her statement almost entirely out of statistics she chose to highlight (backlog down, arrests up) rather than the target she has not hit (ending hotel use by the end of this Parliament). This is a genuinely current example of how a minister uses departmental data to manage a political narrative, a sharper illustration of "core executive" communications strategy than anything an abstract textbook description gives you.

Farage wants to bin the rulebook (while being sued under it)

WESTMINSTER – 26 AUGUST 2026

Nigel Farage and Reform UK's Robert Jenrick used a Tuesday evening press event to promise they would scrap UK GDPR altogether if they ever get the keys to Number 10, swapping it for a lighter touch, New Zealand style privacy law. Labour's Mel Stride said the plan would "collapse on contact with reality." The irony is hard to miss: Reform itself is currently defending a High Court case over allegedly breaching the very data protection rules Farage wants gone.

- The pitch: replace UK GDPR with a regime modelled on New Zealand's Privacy Act, where the maximum fine is measured in tens of thousands of pounds, not the multi-million pound sums GDPR allows.
- Labour dismissed the plan as "unworkable and unserious."
- A High Court judge ruled in June that the Good Law Project's data protection case against Reform UK should go to trial.

WHY THIS MATTERS FOR YOUR A-LEVEL: a party with no MPs in government can still set the weekend news agenda and force the governing party into a public rebuttal. That is a real, current example of how opposition and minor parties exercise power through agenda-setting rather than office-holding, exactly the kind of "functions of political parties" point examiners want illustrated with something more recent than a textbook case study from a decade-old manifesto row.

SCOTLAND



Marra v Fagan: Scottish Labour's fight for survival

HOLYROOD – 24 AUGUST 2026

Scottish Labour is picking a new leader after Anas Sarwar swapped Holyrood for a seat in the House of Lords and a ministerial red box in Andy Burnham's government. The two candidates left standing, Michael Marra and Joe Fagan, spent this week trading blows over who actually wrote the manifesto that delivered Labour's worst devolution-era result back in May. Neither has said much yet about what they would actually do differently.

- Sarwar quit as Scottish Labour leader in July to become a UK government trade minister after accepting a peerage.
- Marra: North East Scotland MSP and former finance spokesperson, running as the unity candidate.
- Fagan: former South Lanarkshire Council leader, running as the "change" candidate.
- The result is announced on 19 September 2026.

WHY THIS MATTERS FOR YOUR A-LEVEL: Sarwar's move is a neat, current example of a route into government that skips the ballot box altogether: a peerage lets a Prime Minister bring a talented devolved politician into a UK ministerial job without them ever facing UK voters. Next time a mark scheme asks you to evaluate the House of Lords' role or the Prime Minister's powers of patronage, this is a sharper example than the usual list of hereditary peers.

WALES



Plaid's first 100 days: more dashboard than delivery?

CARDIFF BAY – 25 AUGUST 2026

Wales's first ever Plaid Cymru led government hit the 100 day mark this week, and the report card is mixed. Free school meals have expanded and a new Cancer Plan is under way, but ministers could not get their own supplementary budget through the Senedd after a row with Labour over funding for pupils with additional learning needs. Opposition parties reckon First Minister Rhun ap Iorwerth's government has been better at launching reviews than fixing anything.

- Plaid Cymru holds 43 of 96 Senedd seats, the largest party but short of a majority.
- Kept promises: expanded free school meals, a new Cancer Plan, a multi-year farmer funding cycle.
- Missed target: the government's own supplementary budget failed to pass.
- Both unemployment and NHS waiting lists have risen since May.

WHY THIS MATTERS FOR YOUR A-LEVEL: this is a live, worked example of what a minority government actually looks like day to day under a proportional system, not the general "coalitions are harder to govern with" line from your notes, but a specific, current instance of a government unable to pass its own budget because Additional Member System arithmetic denies it a majority. Compare it directly with how Westminster's plurality system usually manufactures single-party majorities that avoid exactly this problem.

NORTHERN IRELAND



Burnham goes to Belfast (and Stormont's still skint)

BELFAST – 27 AUGUST 2026

Andy Burnham made his first trip to Belfast as Prime Minister this week, sitting down with First Minister Michelle O'Neill, Deputy First Minister Emma Little-Pengelly and the leaders of every Executive party. He talked cost of living, promised to help sort out Stormont's long running budget row, and confirmed the Troubles legacy bill is coming back to Parliament. Warm words. The Executive has been trying to fix its own budget for months, and a photocall in Belfast will not pay anyone's wages.

- Meeting held 27 August 2026, Burnham's first visit to Northern Ireland as PM.
- All five Executive parties (Sinn Féin, DUP, Alliance, UUP and SDLP) were represented.
- The Northern Ireland Secretary will lead work bringing the Troubles legacy bill back before Parliament.

WHY THIS MATTERS FOR YOUR A-LEVEL: the Troubles legacy legislation is a genuinely current, concrete example of Westminster legislating directly on a matter that touches Northern Ireland, even though justice and policing are devolved in principle, because legacy and reconciliation issues remain reserved to Westminster. Use this specific bill, rather than a generic description of "reserved versus devolved powers," when you need to show an examiner you understand exactly where the line between London and Stormont falls.

ECONOMY & BUDGET



Healey's honesty budget: no drama, just a £1.8bn hole

WESTMINSTER – 28-29 AUGUST 2026

Chancellor John Healey has set 28 October as Budget day, and he needs it to go well. The latest official figures show the government borrowed £1.8 billion in July alone, comfortably missing the independent forecaster's prediction and landing right as Burnham's popularity bump starts to wobble. Healey has been quietly consulting outside economists rather than his own backbenchers, a sign of just how carefully he is trying to look sensible before he actually has to be sensible.

- Public sector net borrowing: £1.8 billion in July 2026, up 68.7% on July 2025.
- That overshoot the Office for Budget Responsibility's forecast by £2.3 billion.
- Former Bank of England deputy governor Andy Haldane has called for a "moratorium on tax increases and regulatory burden" on business, likening it to a "fiscal Hippocratic oath."
- None of Healey's informal panel of outside economic advisers has taken a formal government job.

WHY THIS MATTERS FOR YOUR A-LEVEL: this is a sharp, current illustration of how an unelected body (the OBR) can constrain an elected Chancellor's room for manoeuvre well before a single tax rise is even announced. When you are asked to evaluate limits on executive power, do not just reach for judicial review or select committees; a Chancellor missing an independent forecaster's borrowing target by £2.3 billion in a single month is a live example of technocratic, not just legal or parliamentary, constraint.

Inflation jumps to 2.9%. UK CPI rose to 2.9% in the year to July, the first increase since March, driven mainly by higher energy bills after an Ofgem price cap rise. Worth checking how this shapes the mood heading into Healey's Budget.

Reform UK's internal feuding. Reports this month suggest infighting inside Reform UK is slowing Farage's attempt to professionalise the party ahead of a possible run at government. Worth researching what "professionalising" a rising insurgent party actually involves.

The rest of the reshuffle. Beyond Healey and Cooper's promotions, look up exactly who else moved in or out of Burnham's top team, and what the pattern tells you about the factions inside the new government.

Sarwar's peerage draws criticism. Critics have questioned Anas Sarwar's rapid rise from a Holyrood backbench seat to the House of Lords and a ministerial job. Worth reading up on the wider arguments for and against an appointed second chamber.

Troubles legacy bill returns. The government has confirmed it will bring its Troubles legacy legislation back to Parliament this term. Worth looking into what the previous version of the bill proposed, and why victims' groups on all sides objected to it.
